- 2. Only real estate professionals may promote a listing on tour and must be present to pitch the listing, or it will be removed from the tour. Agents pitch their listing at the end of the meeting during the round table introductions.
- **3.** Properties may not be submitted for tour more than once every 90 days unless there has been a change in the listing broker, or a significant change has taken place in the condition or presentation of the property.
- **4.** The Tour List will be pulled BAREIS using the MLS area code B0800. If your listing is outside that code but you would like to have it included as optional, please attend the meeting and announce.
- **5.** Listings entered after 1:00pm on Tuesday may be added to the tour at the meeting, but they must be in the system. A tour list with summary will be provided at the meeting by the host company for the month.

NorBAR pulls the list and emails a PDF of the tour sheet to the host office of the month. The host office is responsible for printings the tour sheets (approx 85 copies) and bringing them to the meeting by 8 am. Host office also provides an item for the raffle once during the month they are hosts. Everyone is welcome to bring a door prize at any meeting.
